## b. Report on Assessment Payments to Date

The Superintendent shared that as of May 23, 2018, Mercer, Norridgewock and Skowhegan were current on their monthly assessments. Canaan, Cornville and Smithfield are outstanding for May. Assessment payments are due on the 20<sup>th</sup> of each month.

#### c. Other

The Superintendent also reported on the following:

- School Safety Summit was held in Augusta and focused on threat assessments, security awareness and weaknesses.

- The DOE has launched the new online certification system. Once the system is refined the Educator Portal will be released and teachers will be able to renew their certification online.
- The high school may have the opportunity to extend the NEASC accreditation, which expires in 2021, for an additional 3 years.
- \$37,685 was received from MSMA Unemployment Compensation Fund for return of excess contributions.
- Current vacancies were reviewed.
- There are currently 149 incoming Kindergartners registered for the fall.
- KVCAP is proposing adding a 3 year old program, which may create an additional session in the fall.

The Superintendent asked for the Board's approval of a one year unpaid leave of absence for Heidi Goodwin, who will continue working with the Department of Education as a Distinguished Educator.

The Assistant Superintendent also shared news and events taking place in the schools.

The Support Services Manager shared that the next phase of the flooring project at the high school will resume on June 14<sup>th</sup>. The School Nutrition Program will be serving dinner to 0-18 and pregnant women for 6 Tuesdays this summer as part of the Dinner/Movie in the Park that will be held at Coburn Park.
